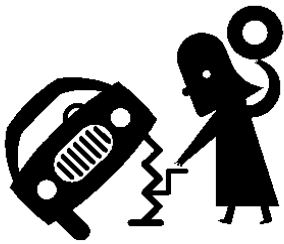

If you received this newsletter in hard copy, it's likely that you've been missing out on important Adopt-a-Forest mail! Most of our communications are by e-mail. Have you replaced your car tires and been asked if you want to pay an additional fee (usually \$2-\$3 per tire) for disposal of the old ones? Your other option would be to take the old tires with you.



This fee is optional and the money is paid directly to the retailer who uses it to cover overhead expenses as well as the cost of disposal. **The state does not require or collect this fee.**

If you do not have easy disposal options (such as curbside pickup of tires), this may be the most convenient method of disposal.

The Cass Community Social Services in Detroit has been collecting scrap tires from vacant lots in the city and turning them into welcome mats.

According to Reverend Faith Fowler, "It's making a difference for the people and the environment. More than 1,000 mats have been made. That means more than 2,000 discarded tires that were illegally dumped are now welcoming people into homes."

Lisa tells us if everyone "adopted" 206.5 square feet – the size of some living rooms – public land in Roscommon County would be clean! Lisa said, "I am hoping that this visual will demonstrate just how small a step is required for each of us to really make a difference on State land."

## **Community Cleanup Guide**
