ABOVE AND BEYOND

It's obvious that volunteers really go above and beyond the call of duty when cleaning up trash on public land...but some are just plain amazing.

The Cherry Capital Paddle America Club conducted a Boardman River Clean Sweep in May of 2007.

Six teams totaling 65 people worked along the Boardman River. A lot of people put their time and effort into planning and fundraising for this project as well as during the cleanup.

The Keystone (Boardman) Pond was the biggest trouble spot because three feet of water was drained behind Boardman Dam, making a lot of trash that was once submerged in water visible. Complicating things was the fact that the trash was sitting in mud that appeared to be bottomless. Most people would just paddle on.

Instead, volunteer Jim Heffner somehow managed to get out of his whitewater kayak and don snowshoes. He then walked across the mud flats and picked up the exposed trash. Visit our website at www.cleanforests.org to see the photos. Someone should send this guy a medal!

Countdown to Digital TVs

Americans with older, analog televisions which received signals by antenna must switch to digital by February of 2009. Subscribers to cable or satellite service should ask their providers if they need special equipment for digital reception. If you don't buy a digital model, a converter box will change digital signals back to analog. The boxes range from \$50 to \$75 each. For more info, go to www.dtv.gov or call 1-888-225-5322.

What does this mean for Adopt-a-Forest? When equipment becomes outdated, we often see a surge in dumping on public land. There are currently 48 known trash sites around the state that have TVs in the pile.

Cathode ray tubes (CRTs), the leaded glass picture tubes found in computer monitors and televisions, contain a high lead content. These CRTs are cause for additional environmental concern when dumped on public land and exposed to the elements.



Have you ever wondered how much the trash you're hauling weighs?

FYI, one pickup load generally holds up to 3 cubic yards.

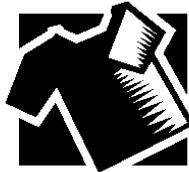
The U.S. EPA uses the following conversion factors:

- Residential waste (uncompacted): 150-300 pounds per cubic yard.
- Commercial-Industrial waste (uncompacted): 300-600 pounds per cubic yard.
- Municipal solid waste (compacted): 500-1,000 pounds per cubic yard.

That's a lot of weight to be throwing around!

Please make sure to use proper lifting techniques when working on trash cleanups. Also, heavy loads can shift when driving, causing accidents. Safely secure your load.

Tax-deductible donations made to the MFRA-Adopt a Forest program are used to further our mission of ridding Michigan of illegally dumped trash.



According to Steven R. Stein, Senior Consultant with R.W. Beck, Inc. in Maryland, it costs \$2,683 per ton to dispose of trash illegally dumped in Michigan's forests.

Steve took the tonnage figures and volunteer hours we provided and calculated them with the disposal costs and a value of volunteer time based on an index of volunteer rates determined by the "Independent Sector" (18.77/hour in 2006).

The cost was averaged over the past four years to account for any abnormal variance. This estimate does not include vehicle or fuel costs or administrative time/expenses paid by sponsoring agencies.

TO THE RESCUE
